Thank you for contacting us about becoming a volunteer! Find The Children welcomes volunteers as they are an invaluable asset in our search for missing children. Our volunteers assist our cause by disseminating information about missing children and helping out at special events as needs arise. Below are descriptions of a volunteer's responsibilities:

Photo-flier distribution – one in seven missing children is found through photo recognition!

Each month, we send each of our volunteers a packet containing three to six fliers, each of a different missing child. Our volunteers then make as many copies as they are able, and post them throughout their communities. We ask that when posting fliers, you do not post them in general public view (i.e. store windows, telephone poles). Instead, post them in places where only the employees/members of that business/organization can view them. There have been cases in which an abductor fled to a different city because he/she saw his/her own photo or the child's photo displayed in public. Also, remember to always ask permission of a manager/owner before posting a flier in their place of business.

Community events:

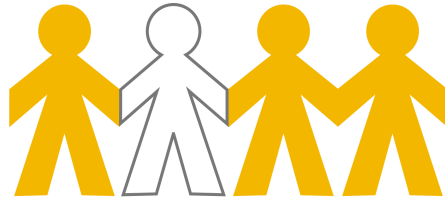

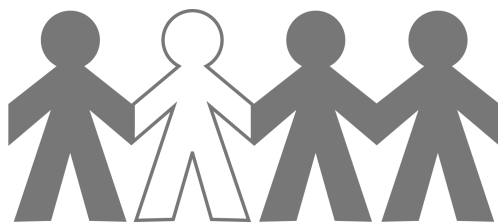
